

# Drop Box Locations

Under Executive Order No. 177, the November 3 General Election will be primarily Vote-By-Mail (VBM) in New Jersey. This means that the general public must Vote-By-Mail instead of the traditional in person voting.

Your VBM ballot will include a return postage-paid envelope and can either be put in the mail OR deposited in one of thirteen (13) secure drop boxes located throughout the County OR delivered directly to the Board of Elections.

### **1. Visit: [TrackMyBallot.nj.gov](https://TrackMyBallot.nj.gov)**

### **2. Sign In or create new account.**

If creating new account, you may need your Voter ID. Your Voter ID is a letter followed by 10 numeric digits which can be found above your address on the YELLOW (not green) Certificate Envelope.

### **3. Click on "Mail-In Ballot History."**

The "Ballot Status" field will designate the status of the ballot. Please note the status of "Received" will not change to "Accepted" until the election results are certified.

# 2020 General Election Information

Under Executive Order No. 177, the November 3 General Election will be primarily Vote-By-Mail (VBM) in New Jersey. This means that the general public must Vote-By-Mail instead of the traditional in person voting.

## Voting by Mail

You should have already received your ballot in the mail.

There is still time to return it; ballots must be received or postmarked by 8:00 p.m. on Election Day, by any of the following options:

**Ballot Drop Boxes** - The 13 locations of Gloucester County's Election Ballot Drop Boxes can be found at [www.gloucestercountynj.gov](http://www.gloucestercountynj.gov)

**By Mail** - You can mail it in the postage paid envelope from any US Post Office or USPS mailbox. It is recommended that you mail it at least a week before the election. If mailing closer to Election Day, it is recommended that you go inside the Post Office and ask the clerk to hand cancel the envelope to assure it has a readable and timely postmark.

**In-Person to the Board of Elections** - Ballots can be returned during normal business hours Monday through Friday 8:30 a.m. to 4:30 p.m. and Election Day 6:00 a.m. to 8:00 p.m. to the Gloucester County Office of Elections, 550 Grove Road, West Deptford, NJ 08066. Since you will be bearing your ballot, identification is required.

**In-Person at Polls on Election Day** - Drop off to your assigned polling place during polling hours. You may only drop off your own ballot; you cannot be the bearer of another voter's ballot.

If you need a replacement Vote by Mail ballot because it is misplaced, torn, or incorrectly marked, or you never received it, please visit [www.gloucestercountynj.gov](http://www.gloucestercountynj.gov). Requests for a replacement ballot by mail must be received by October 23, 2020.

Any later requests must be made in person at the Gloucester County Clerk's Election Division, 550 Grove Road, West Deptford, NJ 08066.
